06/30/2021	Notify Fresno County of offices to be filled. (Three Director seats to be filled. Seats are currently held by Directors Cameron, Moles and Rai)
07/05/2021 to 08/04/2021	Publish Notice of Election in the local newspaper
07/12/2021	Declarations of Candidacy forms available
07/28/20	Deadline to make changes to ballot designation for declarations already submitted.
08/06/2021 by 5:00 pm	Deadline to submit Candidate's Statement. A statement may be withdrawn, but not changed. Deadline for an incumbent to file.
08/11/2021 by 5:00 pm	Deadline for any person other than an incumbent to file.
08/12/2021	If the applicants are less than or equal to the number of open positions, the District can request that the County Board of Supervisors certify the election. At this time, a qualified person can also be appointed to fill any vacant position(s).
08/12/2021	If, and only if, there are more candidates than positions open, the District must proceed with an election that will coincide with the General Election.
9/23/2021	List of qualified voters prepared
10/04/2021	Sample Ballots Mailed
10/19/2021	Last day to file as a write-in candidate
